Success Story, means an experience properly identified in time and context that uses a methodology or more, which produced results that are similar or better than expected.

Best Practice means a strict and empirical construction made up of success stories concerning the use of methodologies, which are repeatable, transferable and able to deliver measurable results in a context with adequately defined conditions.

Each partner conducts an examinations among own specific experiences (e.g. policy, training) independently. After the sheet will be shared by the partners with the aim to create a set of common practices. Naturally the project should produce new best practices as results of the work done with stakeholders and schools.

The proposed selective process, better known as *Moussakà process*, consists in an initial collection of at least one experienced methodology considered by each partner suitable for the project.

The process continues with the distinction in those that can be considered “best practices” and those that can be considered “useful tools”.
